Water level is the customer's responsibility: no water will be added to pool by service tech. A note will be left to inform of low water level.

Cleaning Includes: Skimming, Brushing, Vacuuming, Tile Scrubbing w/ Tile Cleanser, Emptying Skimmer and Pump Baskets. These Items are done on an as needed basis as the dirt load may change from week to week.

Note: Rain, Wind, and Severe weather conditions may prohibit us from cleaning a pool to perfection.

Filter Cleanings are included. Filters are cleaned on a schedule of once every 8 weeks. If filter is too small and needs more frequent cleanings, an additional fee will apply.

Chemicals Included: All Chemicals needed to maintain your water are included.

Repairs to Equipment: No repairs are included with your monthly service. When a repair is needed the service department will issue a work order to the repair department to give you a free estimate for the needed repairs. NO repairs will be done till you approve the Estimate.

Repair to Cleaners: Repairs to Cleaners are done at a parts only price, labor is free and parts are billed at cost.

Access: Customers that have locked gates, it is recommended that we have a copy of the key. If we have no key and customer fails to leave gate unlocked the pool will not be serviced. Chemicals will be left at your door to add. No refund will be given for missed service stops.

Vacations: Service is billed on a monthly basis based on a 4 week month. There are 4 months a year that have 5 weeks 2 weeks are free and 2 weeks are used as vacation for your service technician. Vacations are normally taken in the fall or winter months. You will be notified in advance and chemicals left for vacation weeks.

Service Agreement Terms: The agreement is in effect until canceled. **Either party may cancel this agreement at any time.** All Service is billed one month in advance. Invoices are generated on the 20th of each month giving you a grace period of till the 10th of the next month. If payment, or payment arrangements are not made prior to the 10th of the month service will be stopped and collection process will begin. Service rates are subject to change with 30 days advance notice.
